Personal Views of the Civil War By Bill Bertrand

Recently, MCHS received a request about the letters and diaries held at the museum from Civil War soldiers. Although we have all read about and have seen television and movie depictions of the battles and life during the war, much of what we know comes from research and descriptions compiled years after the war – from hindsight, rather than personal experience. It can be quite interesting to read the perspective of individuals who were living the war as it happened. Some of what was relayed would not be considered "politically correct" in today's society, but accurately reflects attitudes common at the time. If you would like to step back and, perhaps, better understand ancestors of the Civil War era, below is a list of items available at the museum.

*Civil War Letters Written to McCreights of Mercer County by McCreight Soldiers Looseleaf binder includes transcriptions of correspondence from John W. Cavin, Pvt. in Co. A, 30th IL Infantry; W. P. Kimel, Pvt. in Co. A, 30th IL Infantry; E. P. McCreight, Pvt. in Co. A, 30th IL Infantry; Samuel McCreight, Corporal advancing to 2nd Lt., Co. A, 30th IL Infantry; Nathaniel Kirkpatrick, 1st Lt., Co. A, 30th IL Infantry; John S. McCreight, Corporal, Co. G, 30th IL Infantry. Letters were sent to William R. McCreight.

*William Henry Prouty Civil War Letters. Binder of transcribed letters from William Henry Prouty, Pvt., Co. G, 27th IL Infantry. Prouty's relatives, Amos and John M. also served in Co. G. – Amos as a sergeant. William was captured at Franklin, TN, Nov. 30, 1864, and sent to Andersonville.

*Collection of Civil War Letters Written by Mercer County Soldiers. Collection compiled by Gene Kelly in the 1970s, that includes letters to the local newspaper, as well as other letters. Correspondence from S. B. Atwater, Orderly Sgt., Co. G, 27th IL Infantry; William J. Abdill, 1st Sgt., Co. E. 102nd IL Infantry; James Y. Merritt, moving for 1st Sgt. to Captain in Co. K, 102nd IL Infantry; William H. McCoy, Pvt. Co. G, 27th IL Infantry; O. G. Jack, Wm. Hamilton, and A. C. Higgins. Also included in this collection is correspondence to the *Aledo Weekly Record* from Edmun Spangler, who was tried but found innocent of being one of the conspirators in Lincoln's assassination, and Assistant Surgeon, C. S. Taft's graphic description of Lincoln's autopsy, published in newspapers.

***Diary of Reuben Shields** Transcription of diary of **Reuben Shields**, Pvt. in Co. K, 102nd IL Infantry.

*Diary of Thomas J. Simpson Transcription of diary of Thomas J. Simpson, Corporal in Co. E, 102nd IL Infantry. Simpson was wounded at Averysboro, NC in March of 1865 and had an arm amputated.

Of the above list, the situation of Edmun Spangler is an example of how even casual association with the wrong people can cause great grief. Spangler knew John Wilkes Booth from work as a carpenter on

the Booth family home in the 1850s. While Spangler was employed as a stagehand at Ford Theater, Booth appeared in different productions there, and hired Spangler to tend to Booth's horse at a stable nearby. Spangler in turn, hired a boy named Peanut John, to exercise the horse when Booth was out of town. On the night of Lincoln's assassination, Booth asked Spangler to bring his horse to the theater prior to the play. Spangler had to work as a stagehand, so he told Peanut John to hold the horse outside the theater for Booth. Spangler knew nothing of the plot to kill Lincoln, but had been seen talking to Booth when Spangler brought Booth's horse to the theater. Spangler was one of eight people charged as conspiring to kill Lincoln, but the only one found innocent. He did receive a sentence of six years in prison for aiding Booth's escape, although he had no knowledge of Booth's intention when Spangler brought the horse to the theater.
